## THE SEMINAR:

This Second Edition is a comprehensive textbook on mediation for learners and qualified mediators from different backgrounds. Twenty-four chapters are grouped systematically to cover ADR spectrum and principles of mediation, development and the law governing mediation in Hong Kong; practice, processes and techniques of mediation; confidentiality in mediation; cross-cultural mediation; family mediation and mediation in different kinds of disputes which mediators may encounter. For the lawyers, there is a chapter specifically on advocacy in mediation and, for the healthcare practitioners, there is one on mediation in medical and dental disputes. A chapter on apologies in mediation is added to this new edition with the enactment of the Hong Kong Apology Ordinance in 2017. The speaker and commentators will provide an overview of the book, with a focus on medical and dental disputes. They will also discuss how healthcare providers who are not legally trained and nonhealthcare professionals (lawyers in particular) could use this book.

#### James Shing Ping CHIU (趙承平醫生)

Dr. James Chiu is a general mediator and collaborative practitioner. He is the founder of JC Professional Dispute Resolution Centre and has been conducting mediation since 2006. James was appointed the first Adjunct Assistant Professor in mediation courses of the Chinese University of Hong Kong in 2010.

Dr. Chiu was a Vice-Chairman of the Regulatory Framework Subcommittee under the Steering Committee on Mediation of the Department of Justice, and a Member of the Working Group on Apology Legislation. He was also an ExCom member of the HK Mediation Council and an Assessor in general mediation of the HK Academy of Law, HK International Arbitration Centre and HK Mediation Centre. James is a member of the Working Party on Review of the HK Mediation Code, and a member of the Evaluative Mediation Working Group of the HK Mediation Council. He is an Assessor, recognised Lead Trainer and coach of mediation courses accredited by the HK Mediation Accreditation Association Limited (HKMAAL).

Dr. Chiu co-authored the "Hong Kong Apology Ordinance (Cap. 631) Commentary & Annotations" in 2018. He has also published many articles and book chapters and has chaired or spoken in over 100 meetings on mediation, negotiation, apologies and medico-legal issues, in English and Chinese, both in Hong Kong and abroad. James was listed in Who'sWho in the World under the Healthcare profession from 2009 to 2012, and under the Law profession in 2013. He became the first person in Hong Kong invited to join the prestigious International Network for Law and Apology Researchers (INLAR) in 2015.
