#### Dr. Başak Zeynep Baysal, Assistant Professor, Istanbul University Faculty of Law, Istanbul

Dr. Basak Baysal was born in 1978, graduated French Lycée de Saint Benoit in 1996 and Istanbul Universiy Law Faculty in 2000. Same year she was granted Jean Monnet scholarship and admitted in the masters program of Université Panthéon-Assas (Paris II). She began to work in Istanbul University Civil Law Department in 2002 and passed her PhD in 2007. Dr. Baysal has been in Hamburg (MPI), Paris (Sorbonne/Assas) and Lausanne (ISDC) for her doctoral and post-doc studies. She is currently a board member of International Association of Legal Sciences, the Turkish representative of Swiss Institute of Comparative Law, secretary general of the Turkish Committee of Association Henri Capitant and a member of Société de Legislation Comparée. Dr. Baysal is actually assistant professor at Istanbul University Faculty of Law.

### Reverend Dr Christina Beardsley, Head of Multi-Faith Chaplaincy, Chelsea & Westminster Hospital, London

The Revd Dr Christina Beardsley is Head of Multi-Faith Chaplaincy, Chelsea & Westminster Hospital, London and a Visiting Lecturer at St Mary's University College, Twickenham. Vice-Chair of Changing Attitude, England, she co-founded the Clare Project, a transgender support group in Brighton in 2000. Educated at Sussex, Cambridge (St John's College) and Leeds Universities, she is the author of *Unutterable Love: the Passionate Life & Preaching of F.W. Robertson* (Lutterworth Press, 2009).

#### Prof. Richard Chisholm, AM, Adjunct Professor, ANU College of Law, Canberra

After graduating in law from Sydney and Oxford universities, Richard worked as an academic at the Law School at UNSW, specialising in family and children's law. In 1993 he was appointed a Judge of the Family Court of Australia. Since retirement from the bench in 2004, he has resumed academic and law reform work and is currently an Adjunct Professor of Law at the ANU College of Law. He was made a Member of the Order of Australia in 2009.

Since 2010 Member of the Scientific Board of the Federal Association of German Civil Servants.

#### Prof. Dr Josep Ferrer-Riba, Vice-rector of International Relations, Universitat Pompeu Fabra (Barcelona)

Prof. Dr Josep Ferrer-Riba is Vice-rector of International Relations at Universitat Pompeu Fabra (Barcelona) and had previously been Dean of Law at the same university (2006-2010). He holds a chair of Private Law. Ph.D. from the University of Barcelona (1989). Visiting Scholar at the universities of Göttingen (1986-87); Yale, USA (1993-94); Bologna (1999), Leuven (2003) and Puerto Rico (2003, 2012). His main research areas are Family Law, Succession Law, and the Law of Non-profit Organizations, and has been a key participant in the preparatory work for the Catalan legislation in these areas.

#### Mr. Jameson Garland, Department of Law, Uppsala University, Sweden

Jameson Garland is an honors graduate of Harvard Law School (J.D.) and is currently a doctoral candidate in comparative medical law at Uppsala University. He has also served as a lecturer and visiting professor, first at Hofstra Law School (2000-6), then at CUNY School of Law (2006-10). He began his legal career as an attorney for the U.S. Federal Trade Commission, working in health care law. His scholarship focuses on intersections of gender law and medical law.

#### Mr Stephen Gilmore, Senior Lecturer in Family Law, King's College, London

Stephen Gilmore, of Lincoln's Inn, Barrister, is Senior Lecturer in Family Law at King's College London. He is a co-author of *Hayes and Williams' Family Law* (3rd Edition, Oxford University Press, 2012), *Great Debates in Family Law* (Palgrave MacMillan, 2012), and *Children The Modern Law* (4<sup>th</sup> Edition, forthcoming); and co-editor of *Landmark Cases in Family Law* (Hart Publishing, 2011) and *Responsible Parents and Parental Responsibility* (Oxford: Hart Publishing, 2009). Stephen has also published extensively in journals across a range of issues in family and child law. His contributions on the subject matter of this conference include a detailed examination of the decision in *Corbett v Corbett* [1971] P 83 and its impact ('Once a man, always a man?' in *Landmark Cases* above), and a detailed critical examination of the House of Lords' decision in *Bellinger v Bellinger* [2003] UKHL 21 ('Not quite between the ears and between the legs - Transsexualism and marriage in the Lords' (2003) 15(3) *Child and Family Law Quarterly* 295

Her interests include gender legal studies and feminist jurisprudence, equality law, labour law and EU law. She obtained a DPhil from Oxford for her research on "Gender in law under after State Socialism: the example of the Czech Republic".

Athena Nga-chee Liu, Associate Professor, teaches Family Law and Medico-legal Issues at the University of Hong Kong. She is the author of Family Law for the Hong Kong Special Administrative Region (Hong Kong University Press, 1999). Her recent publications include "Exacerbating Corbett: W v Registrar of Marriages" (2011) 41 HKLJ 759), "Understanding Goodwin: W v Registrar of Marriages" (2012) 42 HKLJ 403 and "Gender Recognition: Two Legal Implications on the Law of Marriage" (2013) HKLJ (forthcoming).

#### A/Prof. Elisabeth McDonald, Associate-Professor of Law, Victoria University of Wellington, New Zealand

Elisabeth McDonald is an Associate-Professor of Law at Victoria University of Wellington. Elisabeth teaches and researches in the areas of criminal law, evidence and law and sexuality. Most of her publications discuss issues which arise in all three contexts - for example, hate crimes and sexual offending. Her recent work includes From "Real Rape" to Real Justice (VUP, 2011), Principles of the Law of Evidence (Brookers, 2012) and the forthcoming monograph on the legal position of trans\* and intersex people in Aotearoa New Zealand.

## Prof. Yuko Nishitani, Professor, Private International Law, Kyushu University, Japan

Yuko Nishitani is a Professor of Private International Law at Kyushu University (Japan) since April 2011. Prior to this appointment, she was an Associate Professor at Tohoku University (Japan) from 1997 till 2007. She received a Ph.D. from Heidelberg University (Germany) in 1998 and did research in Italy, France, the U.S., the Netherlands and Switzerland as well. Her research and teaching are focused on private international law, family law and comparative law.

#### Prof.Dr.med. Friedemann Pfäfflin, Ulm University Clinic, Germany

Friedemann Pfäfflin, M.D., was Professor of Psychotherapy and Head of the Forensic Psychotherapy Unit at Ulm University, Germany, until 2010. Trained as a psychiatrist at Hamburg University, he first engaged in transgender clinical work in the mid-1970s when he visited the Psychohormonal Research Unit and the Gender Identity Clinic at The Johns Hopkins University Clinic in Baltimore, Maryland. From 1978 to 1992, he worked at the Institute of Sex Research at Hamburg University, Germany, and continued the work with transsexuals after moving to Ulm University in 1992. His main areas of research are transsexualism, transgenderism, psychotherapy process research, forensic psychiatry and psychotherapy, and history of psychiatry. From 1995 to 1997, he was President of the Harry Benjamin International Gender Dysphoria Association, Inc. Together with Eli Coleman, he founded *The International Journal of Transgenderism* in 1997. He was a member of the subworkgroup *Sexual and Gender Identity Disorders* of the American Psychiatric Association for the revision of the Diagnostic and Statistical Manual of Mental Disorders (APA, DSM-5, 2013).

## Prof. Dr. Walter Pintens, Secretary General of the International Commission on Civil Status, Professor Emeritus, University of Leuven, Belgium

Prof Dr Walter Pintens is the Secretary General of the International Commission on Civil Status, Professor Emeritus of the University of Leuven Honorary Professor of the Saarland University in Germany. He was an Honorary Justice of the Peace in Leuven/Belgium until July 2013 and is a titular member of the International Academy of Comparative Law. He has published widely in Family and Succession Law and Comparative Law and is a founding member of the Commission on European Family Law (CEFL) as well as vice-president of the Wissenschaftliche Vereinigung für Familienrecht and the editor of the volume Family and Succession Law in the International Encyclopaedia of Laws.

## Dr Jens M. Scherpe, Senior University Lecturer in Law, University of Cambridge, England

Dr Jens M. Scherpe, M.A. (Cantab), MJur (Oxon), Dr. iur. (Hamburg) is a Senior University Lecturer in Law at the University of Cambridge and a Lecturer, Tutor and Fellow of Gonville and Caius College, an Honorary Fellow of St. John's College/Hong Kong University and an Academic Door Tenant at Queen Elizabeth Building, London as well as a Fellow of the Hong Kong Centre for Medical Ethics and Law. He has recently published the book 'Marital Agreements and Private Autonomy in Comparative Perspective' and is the initiator and Principal Investigator of the research project on 'The Legal Status of Transsexual and Transgender Persons'.
