

# **Compulsory COVID-19 testing and autonomy**

Our Dr Calvin Ho shared in a recent <u>interview</u> his views on hypothetical compulsory COVID-19 testing schemes, which present a number of ethical and legal considerations. In the interview, reference was made to the right to self-determination in an international covenant to illustrate different concepts of autonomy that are recognised in the law. While the right to self-determination should not be read as forming the basis of a court action to challenge a compulsory testing scheme, it underscores the importance of according recognition and securing trust, even if restrictive measures implemented under such a scheme have legal and public health justifications. Dr Ho will be speaking on this topic in a webinar, entitled "Looking Forward/Looking Back: Law, Ethics, Policy in the Age of COVID-19", to be hosted by the Australasian Association of Bioethics and Health Law on 3rd December (Thursday), 11am (time in Hong Kong). 在最近一次採訪中,本中心何維倫副教授分享了他對假設性 2019 冠狀病毒病強制檢測計劃的看法,強制檢測計劃牽涉不少法律及倫理議題。採訪中提到國際公約中的自決權作為法律認可的各種自主概念的例子。雖然自決權不應作為在法律上挑戰強制檢測計劃的基礎,但是自決權在強制檢測計劃的爭議中無疑是舉足輕重的,鑑於自決(自主)的重要性,即使某個強制檢測計劃所施加的限制在法律上和公共衞生方面有理據支持,爭取對該計劃的認同和信任仍是相當重要的。何副教授將在一場網絡研討會上就該主題演講,該網絡研討會由澳大利亞生物倫理與健康法協會舉辦,題為「向前看/往後看:2019 冠狀病毒病時代的法律、倫理與政策」,將於 12 月 3 日 (星期四) 上午 11 時 (香港時間) 舉行。活動免費,歡迎公眾參與,請於https://www.eventbrite.com.au/e/looking-forwardlooking-back-law-ethics-policy-in-the-age-of-covid-19-tickets-125824463357 報名。
