Prof Gilberto Leung

Co-Director of the Centre for Medical Ethics and Law, Tsang Wing-Hing Professor in Clinical Neuroscience & Associate Dean (Teaching & Learning), LKS Faculty of Medicine, The University of Hong Kong & President of the Hong Kong Academy of Medicine

Gilberto is a neurosurgeon, Clinical Professor, and holder of the endowed Tsang Wing-Hing Professorship in Clinical Neuroscience at the University of Hong Kong (HKU). He graduated from the University of London with MBBS in 1992. During postgraduate training, he was awarded the Hallett Gold Medal and the J. Douglas Miller Medal in Neurosurgery by the Royal College of Surgeons of England and that of Edinburgh, respectively. He obtained his MS, PhD and MD from HKU; LLB from the University of London; and LLM in Medical Law and Ethics with Distinction from the University of Edinburgh. He is currently President of the Hong Kong Academy of Medicine, Co-Director of the Centre for Medical Ethics and Law at HKU, Associate Dean of the HKU medical faculty, and Honorary Consultant Neurosurgeon at Queen Mary Hospital.
